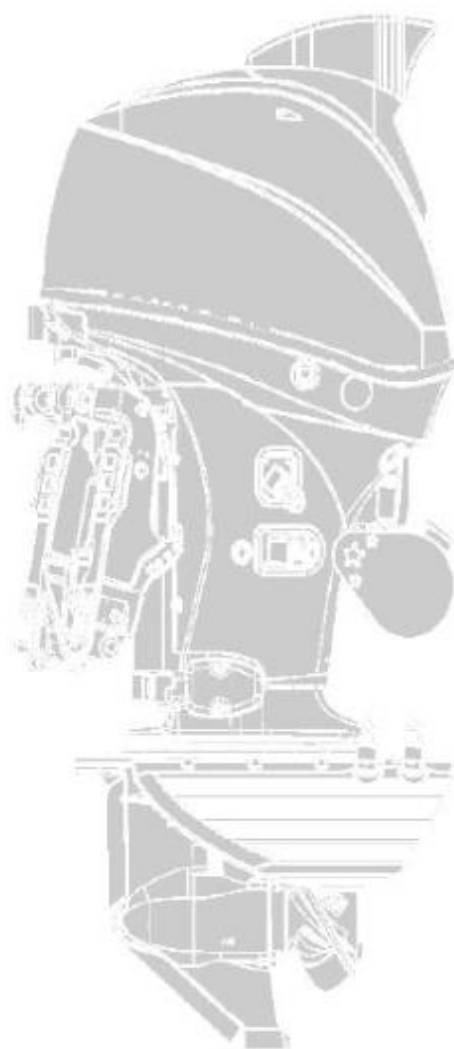

Important Documents

The following documents are important to retain and keep updated.

- Original bill of sale.
- The signed, Pre-Delivery Inspection (PDI) form provided by the FO DEALER.
- The FO DEALER registers the Freedom Outboard Engine within fifteen (15) days. See also, *Contact Information Change or Transfer* pg. 6.
- All Maintenance Records and Receipts, including the Periodic Maintenance Service Records form included with the Owner's manual. It is recommended to log your maintenance records. In the event of warranty claims, FREEDOM OUTBOARD will review any and all service documentation to help determine feasibility of repairs, etc.

2. TERMINOLOGY

FREEDOM OUTBOARD or FO	Freedom Outboard, LLC
WARRANTY HOLDER	Warranty refers to the applicable LIMITED WARRANTY. Holder is the registered owner of the Freedom Outboard Engine or accessories.
FO DEALER	Any authorized Freedom Outboard Dealer
LIMITED WARRANTY	Any applicable part of the Limited Warranty outlined in this document.
Freedom Outboard Engine	Includes Freedom Outboard Engine or accessories, as purchased.
Personal Use	Freedom Outboard Engine or accessories used for any pleasure, non-rental, or non-commercial applications.
Commercial Use	Freedom Outboard Engine or accessories used in any commercial, rental, United States Local, State or Federal Government, or Canadian Government applications.

3. WARRANTY HOLDER RESPONSIBILITIES

After Purchase

WARRANTY HOLDER must obtain from the FO DEALER a signed copy of the Pre-Delivery Inspection (PDI) form. The Pre-Delivery Inspection form outlines the steps the FO DEALER has taken to fulfill its pre-delivery responsibility to properly install and service the new Freedom Outboard Engine.

Note: The selling FO DEALER is responsible for registering the new outboard engine with FREEDOM OUTBOARD.

Engine Care

1. WARRANTY HOLDER must properly operate, maintain and care for the Freedom Outboard Engine as described and outlined in the Owner's Manual.
2. It is recommended that periodic maintenance of the Freedom Outboard Engine is performed by the selling FO DEALER.
3. FREEDOM OUTBOARD highly recommends the WARRANTY HOLDER retain all maintenance and repair receipts.
4. WARRANTY HOLDER must follow the break in tag supplied on the motor and periodic service intervals. If failure to adhere to this requirement, warranty will be voided.

NOTE: FREEDOM OUTBOARD cannot deny warranty solely for the lack of receipts.

Contact Information Change or Transfer

If the WARRANTY HOLDER's name and/or contact information changes, contact FREEDOM OUTBOARD with the changes.

LIMITED WARRANTY coverage for non-commercial, non-rental or non-governmental applications may be transferred to a subsequent WARRANTY HOLDER for the remainder of the applicable LIMITED WARRANTY. To transfer the WARRANTY HOLDER, contact FREEDOM OUTBOARD.

IMPORTANT: Repairs are not covered if the WARRANTY HOLDER has not transferred the LIMITED WARRANTY and notified FREEDOM OUTBOARD within 15 days prior to repairs being performed.

Obtaining LIMITED WARRANTY Service

In order to obtain LIMITED WARRANTY service, the WARRANTY HOLDER must deliver their Freedom Outboard Engine to any authorized FO DEALER.

- The WARRANTY HOLDER is responsible for contacting and arranging delivery of the Freedom Outboard Engine or parts with an authorized FO DEALER as soon as a problem exists. Any authorized FO DEALER may perform warranty repairs to the WARRANTY HOLDER's Freedom Outboard Engine sold and used in the United States, U.S. Territories, and/or Canada.
- If the WARRANTY HOLDER cannot deliver the Freedom Outboard Engine or parts, please notify FREEDOM OUTBOARD. FREEDOM OUTBOARD will arrange for the Freedom Outboard Engine or parts delivery. Delivery Services are not covered under the LIMITED WARRANTY. WARRANTY HOLDER shall pay for all related transportation charges and/or travel time.
- WARRANTY HOLDER shall not, unless requested, by FO, ship the product or parts of the product directly to FREEDOM OUTBOARD.
- WARRANTY HOLDER may be asked to provide:
 - Proof of the original purchase date. This may be available with the FREEDOM OUTBOARD registration, the original sales receipt or the FO DEALER signed Pre-Delivery Inspection (PDI).
 - The maintained Periodic Maintenance Service Records form and/or any receipts and documentation of maintenance and prior repairs.
- FREEDOM OUTBOARD must be notified prior to any warranty repairs or service taking place.
- If the service provided by FREEDOM OUTBOARD or the FO DEALER is not covered by the LIMITED WARRANTY, the WARRANTY HOLDER shall pay for all related labor and material, and any other expenses associated with that service. Any services and expenses not covered under the LIMITED WARRANTY must be approved by WARRANTY HOLDER before any work is performed.
- If the LIMITED WARRANTY service or repair is not completed to the WARRANTY HOLDER's satisfaction, first contact the authorized FO DEALER's management. If the matter is still not resolved, contact FREEDOM OUTBOARD directly.

4. LIMITED WARRANTY TERMS & CONDITIONS

FREEDOM OUTBOARD, warrants each new Freedom Outboard Engine or accessories distributed by FREEDOM OUTBOARD for use in the United States, U.S. Territories, and Canada, to be free from defects in both materials and workmanship according to the specifications listed below.

FREEDOM OUTBOARD's sole and exclusive obligation under this warranty is limited to, at our expense and at our option, repairing or replacing covered, defective parts with new or TOHATSU certified remanufactured parts, or refunding the purchase price of the Freedom Outboard product.

This LIMITED WARRANTY shall not apply to any new Freedom Outboard Engine sold on or after January 1 of the fourth calendar year following the engine's year of manufacture.

LIMITED WARRANTY claims are subject to inspection and approval by FREEDOM OUTBOARD or a FO DEALER to determine applicability. FREEDOM OUTBOARD or the FO DEALER may deny LIMITED WARRANTY coverage if the Freedom Outboard Engine or accessory has failed due to abuse, neglect, or improper maintenance or unapproved modifications.

The approved LIMITED WARRANTY repairs are to be completed in a reasonable amount of time, not to exceed 30 days (depending on availability of parts required for repair) from the acceptance of delivery.

FREEDOM OUTBOARD reserves the right to improve or modify products from time to time without assuming an obligation to modify products previously manufactured.

United States & US Territory Customers

Other LIMITED WARRANTY terms and conditions.

Throughout the entire term if the applicable LIMITED WARRANTY, FREEDOM OUTBOARD shall not be liable for any indirect, incidental, consequential, special and/or punitive damages, lost profits, loss of use, inconvenience, transportation costs, and/or commercial loss.

NOTE: Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply.

Any implied warranty of merchant ability or fitness for a particular purpose is limited to the terms and conditions of the applicable written LIMITED WARRANTY.

NOTE: Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not be applicable.

The applicable LIMITED WARRANTY provides specific legal rights, and any additional rights may vary from State to State. In no event shall the liability of FREEDOM OUTBOARD, under the applicable LIMITED WARRANTY, exceed the original cost of the Freedom Outboard Engine, except as otherwise provided by applicable law.

Canadian Customers

Other LIMITED WARRANTY terms and conditions.

Except as expressly set out in the applicable LIMITED WARRANTY, there are no other conditions or warranties expressed or implied, including the implied conditions or warranties of merchantable quality or of fitness for a particular purpose.

Under Provincial and Territorial laws, the limit of FREEDOM OUTBOARD Liability for any direct damages will not in the aggregate exceed the purchase price paid for the Freedom Outboard Engine. FREEDOM OUTBOARD is not liable in any way whatsoever for any indirect, special, punitive, incidental or consequential damages including, without limitation, lost profits, or business revenue, lost business, or other commercial or economic loss of any kind whatsoever, whether or not such damages are foreseeable.

What is Covered

Freedom Outboard hereby warrants the following components of each new engine sold:

Coverage based on hourly periods is only permitted for engines that are equipped with appropriate hour meters or their equivalent.

Power Head LIMITED WARRANTY

Personal Use: Coverage is provided for a period of five (5) years from the original date of purchase.

Commercial Use: Coverage is provided for a period of two (2) years from the original date of purchase.

Personal Use: Coverage is provided for a period of three (3) years from the original date of purchase.

Commercial Use: Coverage is provided for a period of two (2) years from the original date of purchase.

Drive Train LIMITED WARRANTY

Personal Use: Coverage is provided for a period of two (2) years from the original date of purchase.

Commercial Use: Coverage is provided for a period of one (1) year from the original date of purchase.

Drive Train LIMITED WARRANTY includes:

Emission Control System LIMITED WARRANTY

Coverage is provided for a period of five (5) year or 200 hours of operation, whichever occurs first, for Freedom Outboard Engines initially sold in the United States. This Emission Control System Limited Warranty is applicable to 2001 and later model year Freedom Outboard Engines.

Select emission control parts from model year 2001 and later outboard engines are warranted for two years, or for 100 hours of use, whichever occurs first.

Jack Plate LIMITED WARRANTY

Coverage is provided for a period of one (1) year on the Jack Plate actuator and two (2) years on all fabricated parts for the Freedom Outboard Jack Plates initially sold in the United States.

What is Not Covered

The following are not covered under any of the LIMITED WARRANTIES.

- Damages or failures of the outboard engine resulting from:
 - Accident, theft, fire, misapplication or misuse (proper use is described in the Owner's manual), submersion or freezing due to improper protection / storage.
 - Striking any object.
 - Use of improper, dirty and/or contaminated fuels, fluids or lubricants.
 - Use of parts not equivalent in design and quality to parts supplied or authorized by FO.
 - Any unauthorized modification or alteration or improper repair.
 - Racing or speed contests.
 - Water entering engine through the fuel intake, air intake, or exhaust system.
- Normal cosmetic deterioration, such as rust, corrosion, fading of decal or paint color, peeling of paint or decal caused by climate conditions.
- The use of propeller(s) that do not allow the outboard motor to run in its recommended wide open throttle rpm range.
- The following components are not included in the warranty:
